Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- With other users: when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.
- With Your consent: We may disclose Your personal information for any other purpose with Your consent.

Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is gener ally retained for a shorter period of time, except when this data is used to strengthen the secur ity or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices an d in any other places where the parties involved in the processing are located. It means that t his information may be transferred to — and maintained on — computers located outside of Y our state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

Delete Your Personal Data

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.

Please note, however, that We may need to retain certain information when we have a legal o bligation or lawful basis to do so.

Disclosure of Your Personal Data

Business Transactions
